The terms of this Plan shall commence on the date of the sales invoice and continue for the term indicated on reverse side. All maintenance/repairs shall be completed by issuing Jeweler, or by a repair center of issuing Jeweler's choice. Nothing herein shall obligate issuing Jeweler to repair or replace materials resulting from excessive or abusive treatment of the merchandise other than normal wear and tear.
